BBS staff personally reached out and called all our families in June 2020. We asked them to reflect on what worked and what did not from Spring 2020. We also asked them about their hopes and fears for the upcoming school year in relation to COVID-19. We then sent a reopening update to families in late June with an overview of our process to reopen school. We have discussed our reopening plan at recent school board meetings and will continue to discuss at board meetings in July and August. In mid-August, based on the metrics for Deschutes and Jefferson county, we planned to open school using the CDL-Limited In-Person Instruction model. With the Sept. 1st metrics, were able to open using a Hybrid plan. Since we continue to successfully hold school with no COVID cases, we are now increasing our F2F instruction to 3 full days/week (M, W, F) and two half-days/week (T,Th).

review of our plan. We will be ready to move from our Hybrid model to a CDL, should metrics change. We will report any concerns of local outbreaks to them immediately and follow their advice in how we respond.

### Medical Professionals

- Because of our small size BBS does not employ a school nurse. All staff are trained in basic first aid and CPR and the head teacher is a certified Wilderness First Responder. He will also take the training to administer the COVID-19 test to those exhibiting symptoms at school, per required guidelines. Only students with parent permission will be tested. The staff has and continues to consult with an emergency room physician, Siobhan Gray, who resides in our district.

### Daily Logs

- We will maintain [daily logs](#) associated with our attendance system that also documents symptoms of illness and absences due to illness.
- All logs will be provided to the LPHA on a regular basis.

### Disinfection

- All surfaces will be disinfected throughout the day and at the end of each day. A deeper cleaning will occur each Wednesday afternoon once students have left the building.

### Screening/Isolation

Visual screening of all students and staff is outlined in 1e. Potentially symptomatic students will be isolated following guidance outlined in 1h.

Calculate only with usable classroom space, understanding that desks and room set-up will require <b>use of all space</b> in the calculation. This also applies for professional development and staff gatherings. The MPR has a capacity of 23 people based on a square footage of 814 sq/ft. The solarium has a capacity of 8 people based on a square footage of 312 sq/ft. The district office has a capacity of 7 people based on a square footage of 265 sq/ft. <i>When you consider the book cases, tables, and other equipment, the usable space for people is less. When we put desks in the classrooms and account for physical distancing, we can fit only 13 desks in each classroom. This means the ideal capacity for each room will be 13 students and 2 teachers. Each staff member has the required 35 sq. ft in their office space.</i></li> <li>• We will keep the number of students/staff under these thresholds to allow for everyone to maintain proper physical distancing. We will have upper grade and lower grade students use different entrances when entering the building to avoid clustering of students. Classes will spend most of their day in their assigned classroom. The MPR will be utilized as an additional classroom.</li> <li>• Our current enrollment for K-8 is currently at 25 students. All our students will be here for full days, M, W, F. They will be here for ½ days on T, Th with K-3<sup>rd</sup> grades at school in the mornings and 4-8<sup>th</sup> grade at school in the afternoons.</li> <li>• Ongoing instruction and reminders to staff, students and their families will allow us to follow the comprehensive guidelines.</li> </ul> <p><b>Outdoors</b></p> <ul style="list-style-type: none"> <li>• BBS has a long tradition of using the natural world around us as part of our learning environment. We plan to continue that tradition and even increase the amount of time students are outside. We will take advantage of our established outdoor focus, weather permitting.</li> </ul> <p><b>Recess</b></p> <ul style="list-style-type: none"> <li>• Recess is held outside and the teacher(s) on recess duty will enforce reasonable social distancing practices. Students will be reminded regularly to keep their distance but will not be shamed or punished if they forget. Masks will be required during outdoor activities and at lunch, unless they are eating.</li> </ul>

	<p><b>Field Trips</b></p> <ul style="list-style-type: none"> <li>• We have clear routines about how to “circle up” to create an informal classroom space where every person is 6 feet apart and can engage in a learning activity.</li> <li>• While hiking we will break into smaller groups (usually 3) to allow for easier distancing. Teachers will be responsible for keeping students at a reasonable distance even while outdoors. We plan for almost weekly hikes and/or outdoor educational experiences appropriate for the conditions.</li> <li>• When skiing, students will be required to wear masks, sit with family groups on bus and at tables.</li> <li>• We believe the field trips will be the safest way to deliver some of our academic content, develop our BBS Habits of Work, and allow students to connect to their classmates and teachers.</li> </ul>

Schools must plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. Cohorts may change week-to-week, but must be stable within the educational week.</li> <li>☒ Each school must have a system for daily logs to ensure contact tracing among the cohort (see section 1a of the <i>Ready Schools, Safe Learners</i> guidance).</li> <li>☒ Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.</li> <li>☒ Cleaning and sanitizing surfaces (e.g., desks, dry erase boards, door handles, etc.) must be maintained between multiple student uses, even in the same cohort.</li> <li>☒ Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, grade-level academic content standards<sup>5</sup>, and peers.</li> <li>☒ Minimize the number of staff that interact with each cohort to the extent possible, staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.</li> <li>☒ Elementary staff who interact with multiple cohorts (music, PE, library, paraprofessionals who provide supervision at recesses, etc.) should have schedules altered to reduce the number of cohorts/students they interact within a week. Consider having these staff engage via technology, altering duties so that they are not in close contact with students in multiple cohorts, or adjust schedules to reduce contacts.</li> </ul>	<p><b>Single Cohort</b></p> <ul style="list-style-type: none"> <li>• Our whole school will be treated as a single cohort for the purpose of field trips. However, lower and upper grades will be separated during indoor classroom time.</li> <li>• We have 25 students and 8 staff members to be included in the group. During the day students are divided into three classrooms. We will limit interaction between our three classes while indoors. The groups will be merged together during outdoor activities (field trips, recess, P.E.) where physical distance can be easily maintained.</li> <li>• We will use our daily attendance as a system to track who is here each day. This system will allow for contact tracing if individuals in our cohort become sick.</li> <li>• Students, staff, and facilities personnel will work together to clean surfaces and use hand sanitizer throughout the day.</li> </ul>

<sup>4</sup> The cohort limit is focused on the students experience and their limit of 100 people includes every person they come into contact with, including staff. There is not a limitation for staff in cohort size while care should be given to design and attention to the additional requirements.

<sup>5</sup> Academic content standards refer to all of Oregon state academic standards and the Oregon CTE skill sets.
